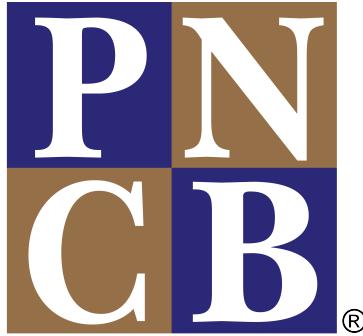

Your PNCB Wallet Card

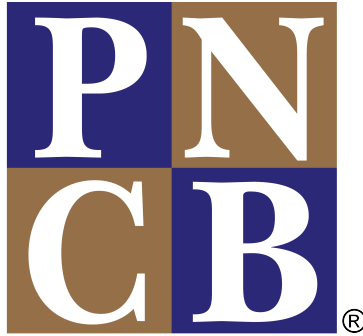
